- 1. (30 points) Please answer the following; you might find it useful to make a sketch.
 - a. For a Normal Distribution that has mean 11 and standard deviation 8.2, what is the area to the right of 20.84?
 - b. For a Normal Distribution that has mean -5 and standard deviation 4, what is the area to the left of -6.6?
 - c. For a Normal Distribution that has mean 12 and standard deviation 4.5, what is the area to the left of 3.45?
 - d. For a Normal Distribution that has mean -14 and standard deviation 7.8, what is the area to the right of -28.82?
 - e. For a Normal Distribution that has mean 8 and standard deviation 9, what is the area to the left of -3.7?
 - f. For a Normal Distribution that has mean -10 and standard deviation 6.8, what is the area in both tails farther from the mean than 4.96?
 - g. For a Normal Distribution that has mean -6 and standard deviation 4.2, what is the area in both tails farther from the mean than -12.72?
 - h. For a Normal Distribution that has mean 10 and standard deviation 6.4, what is the area in both tails farther from the mean than -2.8?
 - i. For a Normal Distribution that has mean -6 and standard deviation 3.5 what values leave probability 0.118 in both tails?
 - j. For a Normal Distribution that has mean -4 and standard deviation 0.1 what values leave probability 0.024 in both tails?
 - k. A regression coefficient is estimated to be equal to 4.32 with standard error 2.7; there are 12 degrees of freedom. What is the p-value (from the t-statistic) against the null hypothesis of zero?
 - l. A regression coefficient is estimated to be equal to -19.11 with standard error 9.1; there are 40 degrees of freedom. What is the p-value (from the t-statistic) against the null hypothesis of zero?
 - m. A regression coefficient is estimated to be equal to -21.16 with standard error 9.2; there are 29 degrees of freedom. What is the p-value (from the t-statistic) against the null hypothesis of zero?
- 2. (30 points) Using a subsample of the taxi data, I find that on weekends there were 193750 rides paid with credit cards and 187694 rides paid with cash.
 - a. Find a 90% confidence interval for the fraction of rides paid in cash.
 - b. On weekdays there were 582335 rides paid with a card and 509798 paid in cash. What is a 90% confidence interval for the fraction paid in cash now?
 - c. Are these proportions statistically significantly different? Explain and calculate t-stat and p-value.
 - d. What are some possible explanations? What data would you want to consider additionally? I'm not (yet) asking for data just an explanation of your thought process.
 - e. Using that data (the smaller sample is on Blackboard) can you construct a knn estimate of which fares are likely to tip more than 15%? OLS estimates of tip amount?
- 3. (30 points) ATUS records the numbers of minutes in a typical day that people spend on various activities. ACT_WORK is the number of minutes spent working; I'll define more than 420 minutes (7 hours) as fulltime.

- a. Conditional on the individual having a HS diploma, what fraction are working fulltime? What is a 95% Confidence Interval?
- b. Conditional on the individual working part-time, what fraction have a Bachelor's degree? What is the 95% Confidence Interval?
- c. Using the data on Blackboard, which is a subset of the ATUS data that selects people who are employed, can you find additional important factors in explaining the time spent at work? Explain with some OLS models and/or knn.
- 4. (30 points) Consider the CEX data; estimate some models to explain APPARPQ, expenditure on apparel in the previous quarter (includes MENBOYPQ, WOMGRLPQ, and FOOTWRPQ expenditure on apparel for Men and boys; Women and girl; footwear). How important is educational attainment on this expenditure category?

- a. What are conditional mean expenditure on apparel for different educational levels? What about conditional means for those who spent a non-zero amount?
- b. Can you estimate some interesting OLS models and discuss the important variables in explaining apparel expenditure? Explain.
- c. Can you estimate further useful models? Explain.
- 5. (25 points) Please answer the following; you might find it useful to make a sketch.
 - a. For a Normal Distribution that has mean -6 and standard deviation 7.1, what is the area to the right of 3.94?
 - b. For a Normal Distribution that has mean 3 and standard deviation 6.9, what is the area to the right of 18.18?
 - c. For a Normal Distribution that has mean 12 and standard deviation 9.1, what is the area to the right of 5.63?
 - d. For a Normal Distribution that has mean 10 and standard deviation 8.7, what is the area to the right of 14.35?
 - e. For a Normal Distribution that has mean -12 and standard deviation 1.1, what is the area to the left of -13.1?
 - f. For a Normal Distribution that has mean -2 and standard deviation 6.6, what is the area to the left of -5.96?
 - g. For a Normal Distribution that has mean 12 and standard deviation 6.3, what is the area in both tails farther from the mean than 8.85?
 - h. For a Normal Distribution that has mean 4 and standard deviation 7.3, what is the area in both tails farther from the mean than 14.95?
 - i. For a Normal Distribution that has mean 12 and standard deviation 5.2, what is the area in both tails farther from the mean than 5.76?
 - j. For a Normal Distribution that has mean 1 and standard deviation 3.1, what is the area in both tails farther from the mean than 7.82?
 - k. For a Normal Distribution that has mean -8 and standard deviation 1.8 what values leave probability 0.278 in both tails?
 - I. For a Normal Distribution that has mean 14 and standard deviation 5.9 what values leave probability 0.222 in both tails?
 - m. A regression coefficient is estimated to be equal to -7.2 with standard error 4.8; there are 10 degrees of freedom. What is the p-value (from the t-statistic) against the null hypothesis of zero?
 - n. A regression coefficient is estimated to be equal to -5 with standard error 2.5; there are 17 degrees of freedom. What is the p-value (from the t-statistic) against the null hypothesis of zero?
 - o. A regression coefficient is estimated to be equal to 5.04 with standard error 2.4; there are 21 degrees of freedom. What is the p-value (from the t-statistic) against the null hypothesis of zero?
- 2. (25 points) Consider an election with generic candidates X vs Y (which we could interpret as chromosomes but not necessarily!).
 - a. Candidate X had the support of 54% of the voters in the latest poll, which had 200 people. What is a 90% confidence interval for the actual level of support?
 - b. If the polling organization were to add 100 more people to the sample size, how much would the 90% confidence interval change?
 - c. Last month's poll had the candidate supported by 51% -- both the previous poll and the current poll had 200 people. Is the difference in polling statistically significant?
 - d. Candidate X must win 2 particular states in order to win the election; the forecast says she has a 60% chance of winning each state individually. Your friend, a wannabe statistician, explains that a o.6 chance of winning one state and a o.6 chance of winning the other means only a o.6*o.6= o.36 chance of winning both so the "favorite" is actually not the favorite! Explain why your friend is wrong.
 - 6. (20 points) Consider the PUMS data for people in NY, that we've been using in class. For now restrict attention to just working people (explain how you might define that).
 - a. Do a statistical test of the difference in average age between working people in the Bronx vs working people in Brooklyn. What is the 95% confidence interval for the difference in means?
 - b. What if you were using the Age data but regularized so that the min is zero and max is one [recall my function, (X_in-min(X_in,na.rm = TRUE))/abs(max(X_in,na.rm = TRUE)-min(X_in,na.rm = TRUE))
 -]. Would the statistical test come out the same? Why or why not?
- 4. (25 points) I used the PUMS data to look at wages and commute type, getting this table for people in the City: (you can answer parts a-c without R)

- a. Given that someone takes the bus to work, what is the probability that they're making wages above \$75,000?
- b. Given that someone takes the subway to work, what is the probability that they make wages below \$25,000?
- c. Given that someone has wage above \$75,000, what is the probability that they drive a car to work?
- d. Using the PUMS data, can you narrow this further what are the socioeconomics of bus/subway in the various boroughs? What is the wealthiest PUMA area and how do the people living there tend to commute?
- 5. (25 points) Use the CEX data that I provided and consider the fraction spent on entertainment, ENTERTPQ/TOTEXPPQ.
- a. Find some descriptive statistics about this fraction, for some subgroups. Tell me something interesting about this data. Are there sub-categories that explain some of the variation?
- b. Create a histogram and/or density plot. What do these reveal?

- c. Estimate a linear regression and discuss what this shows.
- d. Estimate a k-nn classification to predict which households are in the lowest 25% in terms of entertainment spending. Discuss what variables are important in classifying.
- 7. (15 points)) Consider the following simple distribution questions. Your answer can be as detailed as necessary. You might sketch each
 - a. For a Normal Distribution with mean of 12 and standard deviation 0.3, what is area to the right of 12.33?
 - b. For a Normal Distribution with mean of -2 and standard deviation 7.5, what is area to the right of 4?
 - c. For a Normal Distribution with mean of -2 and standard deviation 8.6, what is area to the left of -7.16?
 - d. For a Normal Distribution with mean of -9 and standard deviation o.8, what is area to the left of -8.04?
 - e. For a Normal Distribution with mean 3 and standard deviation 8.9, what is area in both tails farther from the mean than -1.45?
 - For a Normal Distribution with mean 6 and standard deviation 6.9, what is area in both tails farther from the mean than -8.49?
 - q. For a Normal Distribution with mean -4 and standard deviation 5.8, what values leave probability 0.256 in both tails?
 - h. A regression coefficient is estimated to be equal to -o.6 with standard error 1; there are 23 degrees of freedom. What is the p-value (from the t-statistic) against the null hypothesis of zero?
 - i. A regression coefficient is estimated to be equal to 3.04 with standard error 1.9; there are 8 degrees of freedom. What is the p-value (from the t-statistic) against the null hypothesis of zero?
- 8. (20 points) Suppose that a particular medical treatment already improves patient outcomes by 20 (don't worry about the units for now) and it is established that the standard deviation for the population is 8. There is an improved treatment that is expected to deliver a further 10% improvement.
 - a. If there were 10 patients in the trial, what would be the t-statistic, p-value, and confidence interval assuming the new treatment works as expected? Carefully explain the null hypothesis.
 - b. If there were 30 patients, what would be the t-stat, p-value, and confidence interval (again assuming the treatment works as expected)?
 - c. If the company wants a p-value of 5% or lower, how many patients should they plan to have in the trial?
- 9. (20 points) Consider the following table of numbers of people (from CPS data) who make under or over \$15/hr in wage a level that some politicians want to set as the new minimum wage. (This is a particular subset, don't bother trying to replicate, the numbers given here should be sufficient.)

- a. Is the fraction of immigrants making less than \$15/hr different from the fraction making more than \$15/hr? In a statistical test of the difference, what is t-statistic, p-value, and confidence interval?
- b. Is the fraction of people without a HS diploma, making less than \$15/hr, different from the fraction making more than \$15/hr? In a statistical test of the difference, what is t-statistic, p-value, and confidence interval?
- c. In the population of people making less than \$15/hr, what fraction are immigrants without a HS diploma?
- d. What is the conditional probability of finding an immigrant without a HS degree, given that the person is an immigrant and is making less than \$15/hr?
- e. What is the conditional probability of finding an immigrant without a HS degree, given that the person is an immigrant and is making more than \$15/hr?
- 10. (20 points) We consider the co-movement of unemployment and industrial production, comparing the change in the unemployment rate (UR) for months when industrial production (IP) rose against the change in the unemployment rate when industrial production fell, for months since 1975. (Note that UR is measured in percentage points, so a change of .01 means UR went from 5% to 5.01%.)

11. (20 points) Consider a simple regression where hours worked are regressed on a dummy for whether the household is in a rural area and the omitted category is that the person is in a more urban area. (This is a particular subsample of the CEX but I'm not asking you to reestimate, you can figure the answer from the information given here; there are 3595 degrees of freedom). You get the following regression results.

- a. Fill in the blanks in the table.
- b. Suppose you instead looked at the difference in means, between hours worked by urban vs hours worked by rural households. How many hours per week do urban households work, on average? How many for rural? Is that a statistically significant difference?
- 12. (25 points) Using the ATUS data, describe the time spent working (ACT_WORK). Do people with more education work more or less hours than people with less education? What other factors are important? You should choose a variety of methods (perhaps including comparison of means, linear regression, nearest neighbor) that demonstrate your econometric virtuosity. Carefully specify the statistical tests that you perform, including the null hypothesis and test statistics including t-stat and p-value.

Solutions to Some of Previous Questions

- 1. (20 points) Consider the following simple distribution questions. Your answer can be as detailed as necessary. You might sketch each case.
 - a. For a Normal Distribution with mean 12 and standard deviation 0.3, what is area to the right of 12.33? .1357
 - b. For a Normal Distribution with mean -2 and standard deviation 7.5, what is area to the right of 4? .2119
 - c. For a Normal Distribution with mean -2 and standard deviation 8.6, what is area to the left of -7.16? .2743
 - d. For a Normal Distribution with mean -9 and standard deviation o.8, what is area to the left of -8.04? .8849
 - e. For a Normal Distribution with mean 3 and standard deviation 8.9, what is area in both tails farther from the mean than -1.45? .6171
 - f. For a Normal Distribution with mean 6 and standard deviation 6.9, what is area in both tails farther from the mean than -8.49?
 - g. For a Normal Distribution with mean -4 and standard deviation 5.8, what values leave probability 0.256 in both tails? -10.588, 2.588
 - h. A regression coefficient is estimated to be equal to -o.6 with standard error 1; there are 23 degrees of freedom. What is the p-value (from the t-statistic) against the null hypothesis of zero? .5544
 - i. A regression coefficient is estimated to be equal to 3.04 with standard error 1.9; there are 8 degrees of freedom. What is the p-value (from the t-statistic) against the null hypothesis of zero? .1483
- 2. (20 points) Suppose that a particular medical treatment already improves patient outcomes by 20 (don't worry about the units for now) and it is established that the standard deviation for the population is 8. There is an improved treatment that is expected to deliver a further 10% improvement.
 - a. If there were 10 patients in the trial, what would be the t-statistic, p-value, and confidence interval assuming the new treatment works as expected? Carefully explain the null hypothesis.
 - The null is that there is no incremental improvement, so the improved treatment is zero. (Alternately, the null is 20 but if the test works, we would observe a mean of 22). If it really is size 2, then with std dev of 8, the std error of the mean would be $8/\sqrt{10} = 2.52$, so the t-stat would be 2/2.52 = .79, and the p-value is 0.22.
 - b. If there were 30 patients, what would be the t-stat, p-value, and confidence interval (again assuming the treatment works as expected)?
 - With 30, the std error of mean is 8/sqrt(30) = 1.46, so t-stat is 1.37 and p-value is 0.10.
 - c. If the company wants a p-value of 5% or lower, how many patients should they plan to have in the trial?

 They would need at least 54 patients to have a chance of getting p of 0.05 if the treatment works as expected. If it is symmetric then there's only a 50-50 chance of that happening.
- 3. (20 points) Consider the following table of numbers of people (from CPS data) who make under or over \$15/hr in wage a level that some politicians want to set as the new minimum wage. (This is a particular subset, don't bother trying to replicate, the numbers given here should be sufficient.)

a. Is the fraction of immigrants making less than \$15/hr different from the fraction making more than \$15/hr? In a statistical test of the difference, what is t-statistic, p-value, and confidence interval?

There are 4937 making less than 15 and 5863 making more, so this is 45.7% vs 54.3%. The standard error of the sample proportion is sqrt(p(1-p)/n) so 0.0048. The difference of either fraction from 50% is much larger so the t-stat is 8.9 and the p-value is much less than 1%.

- 13. (25 points) Consider the following simple distribution questions. Your answer can be as detailed as necessary. You might sketch each case.
 - a. For a Normal Distribution with mean 2 and standard deviation 5.6, what is area to the right of 10.4?
 - b. For a Normal Distribution with mean -1 and standard deviation 4.9, what is area to the right of -7.86?
 - c. For a Normal Distribution with mean 10 and standard deviation 5.2, what is area to the left of 0.12?
 - d. For a Normal Distribution with mean 7 and standard deviation 4, what is area to the left of 9.8?
 - e. For a Normal Distribution with mean 11 and standard deviation 8.4, what is area in both tails farther from the mean than 19.4?
 - f. For a Normal Distribution with mean -8 and standard deviation o.4, what is area in both tails farther from the mean than -7.52?
 - q. For a Normal Distribution with mean 11 and standard deviation 6.3, what is area in both tails farther from the mean than 0.29?
 - h. For a Normal Distribution with mean 10 and standard deviation 1.5, what is area in both tails farther from the mean than 12.7?
 - i. For a Normal Distribution with mean -1 and standard deviation 1.2, what is area in both tails farther from the mean than 1.52?
 - j. For a Normal Distribution with mean 9 and standard deviation 4.9, what values leave probability 0.08 in both tails?
 - k. For a Normal Distribution with mean 3 and standard deviation 9.6, what values leave probability 0.311 in both tails?
 - l. A regression coefficient is estimated to be equal to 8.25 with standard error 7.5; there are 35 degrees of freedom. What is the p-value (from the t-statistic) against the null hypothesis of zero?
 - m. A regression coefficient is estimated to be equal to 10.08 with standard error 5.6; there are 7 degrees of freedom. What is the p-value (from the t-statistic) against the null hypothesis of zero?
 - n. A regression coefficient is estimated to be equal to -12.04 with standard error 8.6; there are 14 degrees of freedom. What is the p-value (from the t-statistic) against the null hypothesis of zero?
- 14. (20 points) A recent report asserted that people who worked more hours also tended to be fatter (among those in certain occupations). (The paper doesn't give precise numbers so I'll make them up don't bother with Google.) The paper did much more econometric analysis of course. Nevertheless, suppose that, of the 7219 women working non-strenuous occupations, 23% are working more than 40 hours/week. Of those women in non-strenuous occupations working more than 40 hours/week, 27.3% were obese; of those women in non-strenuous occupations working less than 40 hours/week, 24.6% were obese. There were also 714 women in strenuous occupations with 21% working more than 40 hours/week. Of the women in strenuous occupations working more than 40 hours/week, 28.1% were obese while 37.4% were obese among those working fewer hours. Does it seem likely that overtime makes certain groups more likely to be obese? J Abramowitz, "Working Hours, Body Mass Index, and Health Status: A Time Use Analysis"
- 15. (20 points) I used the CEX data to look at the fraction of spending going to health insurance. I get the following table, grouped by education of the reference person:

- a. Conditional on the reference person having a college degree (Associate's, Bachelor's or Advanced), what fraction devote more than 20% of spending to health insurance?
- b. Conditional on the reference person having less than a college degree, what fraction spend more than 20% on health insurance?
- c. Is this difference statistically significant?
- d. What is the overall share (in this sample) of people with any college degree? What share of people spending more than 20% is made up of people with any college degree?
- e. Are those break points (+/- 20%; any degree) reasonable? Can you suggest better? Explain.
- f. What problems might there be, with the classification and analysis here? Can you do better with the CEX data?
- 16. (10 points) One of the first notes in class emphasized "know your data." You've done a few homework assignments using Consumer Expenditure Survey data, tell me about that data. How do they calculate expenditure on food away from home?
- 17. (20 points) I will consider a simple question of the relation of employment to production relevant both for questions of "jobless recovery" and worker productivity. In the R dataset, "macro_datal.Rdata", I give monthly data for the US on payroll (total nonfarm), the unemployment rate, and an index of industrial production for the period from February 1948 to August 2014. There is also a dummy variable for when the US was in a recession (as defined by NBER). The dataset has both the level of each of these (denoted $lvl_{}$) and log difference (denoted $ld_{}$), where $ld_{}z(t) = log(lvl_{}z(t)) log(lvl_{}z(t-1))$. You can use the command, $load("macro_datal.RData")$, to get the data in. I estimate the following regression for the period from 2000-date:

$$\frac{dPayroll}{Payroll} = .000739 + .0512 \frac{dProduction}{Production} - .00270 Recession$$

The intercept coefficient has standard error of .00011, the slope coefficient on percent change in production has standard error or .0161, and the Recession dummy has standard error of .0003. The R-squared is 0.4943.

- a. What is the t-statistic for the slope coefficient? What is its p-value? (Carefully specify the null hypothesis.) What is a 95% confidence interval for the slope coefficient?
- b. Suppose that next month (not a recession month), the percent change in production is 0.004 what would the regression predict is the percent change in payroll?
- c. How would you critique this regression? What might be improved?
- d. Can you find some other interesting results from the data given? Explain.
- 18. (25 points) Using the CPS dataset, form a regression explaining the amount of wage and salary earned by workers. Consider the question, does it pay to get a college degree? What do the data tell us about this?
- 1. (15 points) You might find it useful to sketch the distributions.
 - i. If a variable has a Normal Distribution with mean 9 and standard deviation 9, what is area to the right of -8.3?
 - ii. For a Normal Distribution with mean 5 and standard deviation 0.4, what is area to the left of 4.7?
 - iii. For a Normal Distribution with mean 6 and standard deviation 0.3, what is area in both tails farther from the mean than 5.7?
 - iv. For a Normal Distribution with mean -2 and standard deviation 3.8, what is area in both tails farther from the mean than 2.9?
 - v. For a Normal Distribution with mean 6 and standard deviation 7.5, what is area in both tails farther from the mean than -2.3?
 - vi. For a Normal Distribution with mean 14 and standard deviation 3.4, what values leave probability 0.292 in both tails?
 - vii. For a Normal Distribution with mean 8 and standard deviation 2.6, what values leave probability 0.253 in both tails?
 - viii. For a Normal Distribution with mean -11 and standard deviation 2.6, what values leave probability 0.420 in both tails?
 - ix. For a Normal Distribution with mean 2 and standard deviation 4.7, what values leave probability 0.007 in both tails?
 - x. For a Normal Distribution with mean -10 and standard deviation 7.9, what values leave probability 0.156 in both tails?

- i. A regression coefficient is estimated to be equal to 1.902 with standard error 1.5; there are 26 degrees of freedom. What is the p-value (from the t-statistic) against the null hypothesis of zero?
- ii. A regression coefficient is estimated to be equal to 12.942 with standard error 9.6; there are 8 degrees of freedom. What is the p-value (from the t-statistic) against the null hypothesis of zero?
- iii. A regression coefficient is estimated to be equal to 3.647 with standard error 2.6; there are 15 degrees of freedom. What is the p-value (from the t-statistic) against the null hypothesis of zero?
- iv. A regression coefficient is estimated to be equal to -5.130 with standard error 3.5; there are 17 degrees of freedom. What is the p-value (from the t-statistic) against the null hypothesis of zero?
- v. A regression coefficient has standard error 2.40; there are 14 degrees of freedom. The t-statistic is 2.5994. What is the coefficient?
- vi. A regression coefficient has standard error 3.40; there are 28 degrees of freedom. The t-statistic is -1.4877. What is the coefficient?
- vii. A regression coefficient has standard error 2.30; there are 12 degrees of freedom. The t-statistic is -1.0175. What is the coefficient?

 - c. Compare the two regressions. What are the arguments in favor of using the whole sample versus only more recent data?
 - d. For the most recent data (first quarter of 2012), GDP growth was 0.93 while UR was -0.4. What was the predicted value from each model for that time? How would you interpret this?
- 6. To investigate an hypothesis proposed by a student, I got data, for 102 of the world's major countries, on the fraction of the population who are religious as well as the income per capita and the enrollment rate of boys and girls in primary school. The hypothesis to be investigated is whether more religious societies tend to hold back women. I ran two separate models: Model 1 uses girls enrollment rate as the dependent; Model 2 uses the ratio of girls to boys enrollment rates as the dependent. (15 points) You might have missed this in the news about Alice Munro winning the Nobel, but there was a study done, showing that reading literature such as Munro and Chekov tended to make people score higher on psychological tests of Affective Theory of Mind. Consider the difference between two groups of people: either they read from a selection of literary fiction or they read non-fiction articles about non-human subjects (e.g. potatoes). They were all given a test to determine how well they could identify emotion from a picture of a person's eyes. (I'm making up some of these numbers.) The Fiction group tests at 25.6 with standard deviation of 4.38; the Non-fiction group tests at 23.5 with standard deviation of 5.17. There were 41 people in the first group and 45 in the second group.

In 2012, more than 70% of the companies had positive returns on about 25% of the days; on another 25% of the days fewer than 30% had "up" returns. On the days following "70% up" days, the average return was .06 percent, with standard deviation of 1.72; on days following "30% up," the average return was .10 percent, with standard deviation of 1.66. There were 65 days of 70% or more up; there were 59 days of 30% or fewer up.

There were 137 workers and 14 managers answering.


